COMMUNITY CENTRES AND NEIGHBOURHOOD HOUSES

We have over 100 members ranging from small independent Community Centres and Neighbourhood Houses through to larger council or agency funded ones. We have been representing and advocating for this sector for over 35 years, they are deeply embedded in our DNA. Membership fees start at \$130.

COMMUNITY CONNECTORS

Our diverse Community Connector organizations share our ethos and values but do not represent Community Centres and Neighbourhood Houses. They join us in advocating for strong, healthy communities and addressing inequality, poverty, and disadvantage. They value the networks, partnerships, and advocacy our membership offers. Membership fees start at \$160.

FRIENDS AND HONORARY MEMBERS

These individuals share our ethos and values but do not represent Community Centres and Neighbourhood Houses. Membership fees start at \$50. This category also includes peak body organizations with reciprocal rights and honorary members who display exemplary skill and commitment. There are no fees for this membership type.
